The organization provides assistance to an orphanage in the Philippines in creating quality environments for the children and in providing funds for operation and expansion. It manages a child sponsorship program and operates a summer hosting program for older orphans as a means of

Provided funds for and helped with renovation of the older children's environments. Conducted staff training. Covered travel expenses for missionaries to help with overseas projects including airfare, meals, lodging, etc.

Provided home study services to adoptive families; acted as the placing agency in 16 international adoptions from the Philippines; conducted monthly adoption support groups; provided adoption financial assistance through a grant fundraising program.

Conducted a summer hosting program for older orphans from the Philippines. Eight children participated and were hosted in different parts of the US including Wyoming, Montana and Georgia. Covered the cost of bringing the children plus two escorts which include visas, passports, airfare, escort stipend, medical travel insurance, etc. Scholarships were provide to 4 children to attend school in the Democratic Republic of the Congo out of excess summer hosting program funds.
